That the Company (Emmetts Service Centre Limited) may withhold its services to any customer whose account is past due until such time as the account is paid.

That the Company may hold my personal information and, notwithstanding the provisions of the Privacy Act 1993, obtain any information required to determine the whereabouts and credit worthiness of the customer.
